

## **2007 Agenda for the Wyoming Association of Municipal Courts**

The primary focus of this year's meeting will be juvenile justice. There is little doubt that the fallout of the Virginia Tech massacre and the re-awakened fears of Columbine will cause a greater focus on juveniles. It is possible that juvenile "behavioral issues" that may have passed as an isolated incident or viewed as "minor problem" will be viewed in a different light now. Therefore, municipal courts can expect to see an increase in the number of juvenile cases filed.

It is reasonable to assume that juvenile behavioral concerns will take center stage at all levels of education. The threshold at which problems can be handled "in the school" will probably be lowered. Students with a history of "problems" may also face obstacles with admission decisions for all levels of post secondary education. In light of these projected developments, the disposition of a juvenile case must now factor in the immediate and long lasting impact on a juvenile's future.

The goal of the presenters on juvenile topics will be to highlight the present status of juvenile justice, help identify strategies to work with juvenile issues and also to identify resources to assist with handling juvenile matters. A further goal will be to assist parents, educators and citizens in understanding the shared responsibilities to address juvenile needs.

A second topic of discussion will be consideration of procedures used in municipal courts. The Wyoming State Bar's Unlicensed Practice of Law Committee has raised concerns regarding law enforcement officers prosecution cases in municipal courts. The Committee maintains that a law enforcement officer presenting a citation in court without a prosecutor is engaged in the unlicensed practice of law. A member of the Unlicensed of Law Committee will be present to explain their concerns and provide for a question and answer opportunity. We will have a roundtable/workshop to discuss to forge the Association's response to this matter.

Municipal court security will be discussed in a special session. Wyoming has been fortunate not to experience any recent publicized court disturbances. While that is good news, it is only realistic to expect that each municipal court must take all reasonable security safeguards to protect court staff and citizens visiting the court house. We will also discuss matters involving data security with an emphasis on electronic data management and document control.

Understanding new lawyers will be a topic of a presentation by Dean Denise Burke of the University of Wyoming Law School. She will share her perspectives on the needs and strengths of new attorneys. The goal of this session will be to bridge the gap between judges and court staff that have been "around a while" and new attorneys "fresh out" of law school.

There will also be an opportunity to discuss the "Crow" decision and how to develop practices and procedures to avoid even the mere appearance of impropriety.
